An open plan kitchen, dining area, living room area and a half bath are on the second (main) floor.

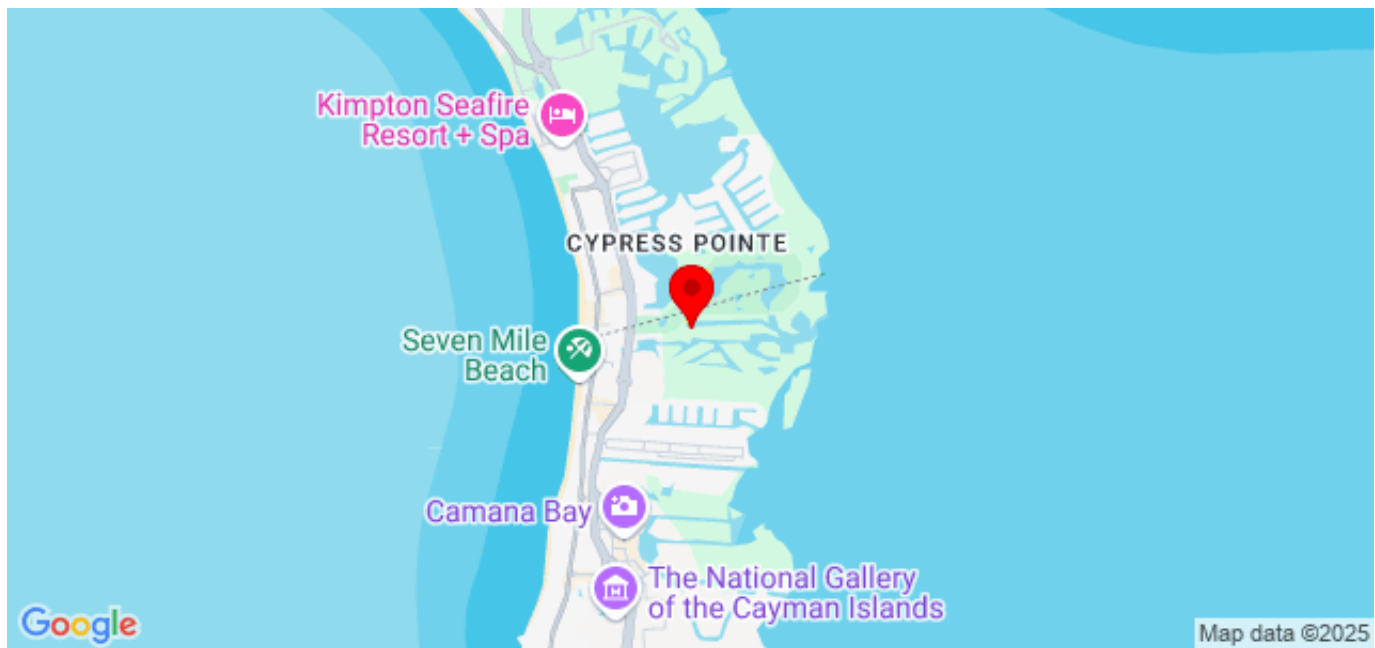
Two very spacious bedrooms, each with full baths and a walk in closet with plenty of storage are located on the third floor.
